The District will consider and act upon the following matters:

12. To review and approve expenditures required for the construction, repair, maintenance and replacement of the District's real property, facilities, signage, vehicles, apparatus and equipment.
13. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
14. To review and act on the purchase, sale or lease of real property, including financing.
15. To create, modify or adopt ESD policies and procedures.
16. To review, discuss and act on creation of District logo for HCESD 4 by way of holding a contest in which surrounding area school students enter artwork for same.
17. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.

18. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
19. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
20. To review and act on matters discussed in closed session.
