

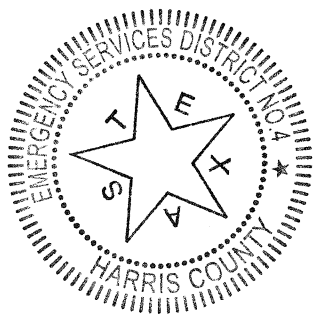
MEETING NOTICE
HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 4

Notice is hereby given that the Board of Commissioners of the **HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 4** will hold a meeting on **November 9, 2020** at **6:00 p.m.** at the **District Administration Building** located at **12207 Huffman Oaks Ln., Huffman, Texas 77336.**

The District will consider and act upon the following matters:

1. Call to order and recite the pledge of allegiance.
2. Roll Call and establishment of a quorum.
3. To receive public comment.
4. To approve the Minutes of prior meeting(s).
5. To receive a report regarding applications for FEMA grants arising from emergency services rendered during Hurricane Harvey.
6. To receive and approve the District's financial report, including the financial condition of the District and the District's investments.
7. To pay the District's bills.
8. To review and modify the District's 2021 budget.
9. To review and take action on the ratification of a continuing Contract with a private law firm pursuant to §6.30 of the Tax Code for the collection of delinquent District ad valorem property taxes and, providing for the payment of up to 20% of the delinquent taxes, penalties, and interest which are collected by the attorney under said Contract.
10. To discuss and take action on the imposition of additional penalty on delinquent taxes pursuant to §33.07 of the Tax Code and adoption of a Resolution regarding same for taxes.
11. To discuss and take action on the imposition of additional penalty on delinquent taxes to defray costs of collection by the District's delinquent tax attorney, pursuant to §33.08 of the Tax Code and adoption of a Resolution regarding same.
12. To discuss and take action on the imposition of early additional penalty for collection costs for taxes imposed on personal property on delinquent taxes pursuant to §33.11 of the Tax Code and adoption of a Resolution regarding same.
13. To receive a report from Huffman EMS.
14. To receive a report from the fire department.
15. To review and take action on matters related to COVID-19, including but not limited to meeting procedures, emergency expenditures and continuity of operations per Government Code §418.1101
16. To review and approve requests for training made by District personnel.
17. To review, discuss and take action on the acquisition and financing of new vehicles, equipment, and apparatus.
18. To review and approve expenditures required for the repair, maintenance and replacement of the District's real property, signage, vehicles, apparatus and equipment.

19. To review and approve expenditures required to conduct a feasibility study for construction of an administration building at 12210 Huffman Oaks.
20. To receive presentations from architects or engineers, or to discuss proposals previously submitted by architects to conduct the feasibility study.
21. To review, discuss and take action regarding the modification, repair, and installation of surveillance and security systems at District properties and facilities.
22. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
23. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
24. To review, discuss and take action on employee benefits and health insurance for the District's employees.
25. To create, modify or adopt ESD policies and procedures.
26. To discuss District personnel matters including compensation, benefits, scheduling, retention, hiring and/or termination of District employees.
27. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
28. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
