14. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
15. To create, modify or adopt ESD policies and procedures.
16. To review, discuss and act on District personnel matters including compensation, benefits, scheduling, retention, hiring and/or termination of District employees.

To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
18. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
19. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.

20. To review and act on matters discussed in closed session.
21. To review and discuss matters for addition to future agendas, and set the date of upcoming meetings.
